The Fed has dual mandates regarding Employment and Inflation. Unfortunately inflation over the past12 month period came in at $6.80 \%$ which the largest since 1982 and is considerable above the 10 Year Treasury annual yield of $1.52 \%$. The Dec CPI results are due out Jan 12 while the next Fed meeting is Jan 26. Be prepared for market volatility.
