

When COVID started to take hold in early 2020 the Fed took decisive action to lower rates. 10 Year Treasuries dropped immediately while Mortgage Rates were slower to react---as such the spread between the rates skyrocketed. Eventually mortgage rates feathered down and the spread decreased to 177 which is only 9bp above the history average of 168bp (green line)
